### 3. Delivery

### 4. Right of Withdrawal

There is no right of withdrawal for purchases of:

- Event tickets (VIP and Social Ride)
- Expo stands
- Advertising caravan spots

in accordance with applicable consumer protection legislation.

All purchases are binding.

## **5. Changes to the Event**

The organizer reserves the right to make changes to:
